- **2.** The stockiest has to maintain a minimum stock of every product always.
- **3.** Stock point is non-transferable. In exceptional cases, the stock point holder has to take prior written consent of the Company for transfer of Stock Point.
- **4.** Stockiest shall only purchase products directly from the Company.
- 5. Stock points which are unable to do minimum billing for consecutive 3 months will be automatically cancelled. Min. billing value: Rs.30000 for any of this 3 months.
- **6.** The stockiest has to raise invoice of every sale at the Point of Sale only.
- **7.** Company will borne a fixed amount as transportation charges if the order value is Rs.50, 000 or above. No cash re-imbursement of transport charges would be entertained.
- **8.** After receiving, within 48 hours the stockiest has to contact nearest branch for any missing or damage products.
- **9.** The Stock Point Holder cannot stock, promote or sale any other products similar or may be in competition to the PITRASHISH Products.
- 10. No credit would be allowed.
- **11.**Stock Point Commission would be calculated as per Company Norms upon total monthly business.
- **12.** Stock Point Commission would be sent to bank account directly after deducting TDS (as per Govt. Rules).
- **13.** No order which has been accepted by the Supplier may be cancelled by the Company.
- **14.** Stockiest is not allowed to return products and request for refund.
- **15.**Company reserves the Right to change / discontinue / modify the stock point operating procedure at any time.
- **16.**Company has all the rights to suspend / terminate any stock point if found any dispute or malpractice.
- **17.** All disputes should be solved under Kolkata jurisdiction only.
- **18.** The stockiest shall operate and carry out its business strictly in accordance with the Company's policy.

**RE-STRUCTURE OF TERRITORY The Company has full rights to re structure the territory as and when required. The Company has full right to increase numbers of SUPER STOCKIST / DISTRIBUTOR for said territory.
**DELIVERY: The delivery of material shall be affected as early as possible depending upon the availability of suitable/appropriate transportation means. However, we shall try to adhere the delivery schedule agreed by us.
**If on delivery any of the Goods are found defective/missing in any material respect, the supplier shall replace or contact the nearest branch within 24hrs or lesser time as agreed by the supplier.
**PERIOD OF DISTRIBUTOR SHIP: The agreement shall initially be for a period of one year commencing from dateto date of signature. The same can be further extended on satisfactory performance. In case of unsatisfactory performance of this contract THE COMPANY will have the right to set aside this contract after giving 30 days notice to the buyer and the outstanding dues of the company shall be recovered from security deposit available with the company.
**Force Majeure clause:- No liability under the contract will arise if either party fails to honor the contract for any reason like strike, riots, acts of God, was, natural calamity and such similar things.
